# **CARROT GARDEN** ICE CREAM DESSERT RECIPE

This festive Carrot Garden is the perfect dessert for

serving during the Easter holiday. Your kiddos will be sure to love it!

#### **INGREDIENTS**

- \* I package (15-1/2 ounces) Oreo cookies
- \* I-I/2 quarts vanilla ice cream
- \* I carton (8 ounces) frozen whipped topping, thawed
- \* 1/2 cup canned vanilla frosting
- \* Orange paste food coloring
- \* 2 to 3 pieces pull-apart green apple licorice

# **DIRECTIONS**

- \* Finely crush half of the cookies; coarsely crush the remaining cookies.
- \* In a large bowl, beat ice cream, whipped topping and finely crushed cookies until blended. Spread into an 8-in. square dish; sprinkle with crushed cookies. Freeze until
- \* Tint the frosting orange; pipe carrot tops in rows over dessert. Cut the green apple licorice into 1-in. pieces; separate strands, leaving one end intact. Place on carrots to form stems.

# **NATIONAL FAIR HOUSING MONTH**

April is the month when we celebrate National Fair Housing Month. In this month we feel grateful for the Fair Housing Act that was passed on April 11, 1968.



America, in every way, represents equality of opportunity for all persons. The rich diversity of its citizens and the spirit of unity that binds us all symbolize the principles of freedom and justice upon which this nation was founded. That is why it is extremely disturbing when new immigrants, minorities, families with children, and persons with disabilities are denied the housing of their choice because of illegal discrimination.

The Department of Housing and Urban Development (HUD) enforces the Fair Housing Act, which prohibits discrimination and the intimidation of people in homes, apartment buildings, and condominium developments—in nearly all housing transactions, including the rental of housing.

Equal access to rental housing opportunities is the cornerstone of this nation's federal housing policy. Housing providers who refuse to rent to people based on race, color, national origin, religion, sex, familial status, or disability are violating federal law, and HUD will vigorously pursue enforcement actions against them.

HUD has proposed a rule that would recognize additional sets of standards and model building code editions that, when followed, will ensure compliance with the accessibility requirements of the Fair Housing Act.

Today's housing challenges are very considerable and there are no easy solutions, but the many initiatives HUD has underway are doing a lot to level the playing field.

Nearly 54 years after the Fair Housing Act was passed, HUD remains firmly committed to creating a nation where every American has the same access to quality, affordable housing and economic opportunity!
